In fiscal 2020, the Cape and Islands Veterans Outreach Center provided 989 counseling sessions, CIVOC Staff delivered 220 counseling sessions. Grace Veterans Program provided 347 holistic therapy sessions. The Food Pantry served food on a weekly basis to 1437 veteran families. Supportive Services for Veteran Families Program provided \$161,733 in first month & security deposits or rental arrears to 86 individuals & 22 families who were either homeless or in danger of homelessness, provided case management, as well as all of our other services to 57 homeless veterans, and made 20,404 contacts in the community through our outreach effort. Additionally, construction began on a new 5-unit transitional supportive housing property in Dennis Ma.
